*New Fords are supplied by an award-winning Ford dealer on the South Coast of England, who will deliver our customers' cars to Southampton docks, free of charge. Cars will be UK registered in your name as first owner, on a pink log book. Thus when you take it back to the UK at the end of your tour, it will not be considered to be an import. (Imported cars have reduced value in the UK).
